香港冰球協會(HKIHA)正式公佈香港女子冰球代表隊(HKWNIHT)將會參加 2016 年國際冰球聯合 會世界女子冰球錦標賽第二組別 B 組資格賽將會(在保加利亞舉辦)。參賽隊伍包括: 保加利亞, 香港, 南非及羅馬尼亞。

本會很感謝所有參與 2014/2015 香港女子冰球代表隊活動計劃的球員。香港女子冰球代表隊於 2015 年 2 月首個在香港舉辦的國際冰球聯合會世界女子冰球錦標賽中擊敗了保加利亞及南非而取得銀牌,目前世界排行第 37 位,這是奠定了重要的根基。



INFORMATION FOR 2015/2016 HONG KONG WOMEN'S NATIONAL ICE HOCKEY TEAM PROGRAM

HongKong Ice Hockey Association (**HKIHA**) is proud to announce that Hong Kong Women's National Ice Hockey Team (**HKWNIHT**) will participate in the 2016 IIHF Ice Hockey Women's World Championship Division II Group B Qualification (in Bulgaria). Participating teams are Bulgaria, Hong Kong, South Africa and Romania.

We are grateful to all the players who participated in the 2014/2015 HKWNIHT program. Hong Kong hosted its first female international world championship in February 2015, finishing 2nd overall beating South Africa and Bulgaria in the round robin. HKWNIHT is now ranked 37 in the world.

With the help and contribution from the present and future players in the HKWNIHT program we are confident that collectively we shall continue to grow and to develop women's ice hockey in Hong Kong. By doing so, the 30 selected players who will be part of the 2015/2016 HKWNIHT program will be expected to be committed to the program as well as to help the youth development program in Hong Kong.

Hong Kong will be participating in the 2016 IIHF Ice Hockey Women's World Championship Division II Group B Qualification in Bulgaria (7th – 11th December 2015). Yet to be confirmed, HKWNIHT may participate in the 13th Chinese National Winter Games held in Xinjiang in January 2016

Applications are now open to all women hockey players who wish to participate in 2015/2016 HKWNIHT program.

No payment will be necessary at this moment. Once you have applied and have attended try outs, players will be selected onto 2015/2016 HKWNIHT Program at which time payment will be collected.

If you are out of town, you can apply through email. All the proper documents must be sent to HKIHA before Tuesday, 5 p.m. (Hong Kong Time 4th August 2015. Your application will be considered by the Executive Committee members and they will decide whether they will accept your application or not

If you have more than 1 nationality, your eligibility to play will need to go thru the IIHF eligibility check before you are allowed to participate in the World Championships. Please see below for more details about IIHF eligibility check and what the process is before you will be allowed to play. In the meantime, you will need to submit your application first, once you have been accepted by the Executive Committee, we will process your eligibility with IIHF which will required you to provide the proper documents accordingly.

If you are interested but you only have HKID card and eligible to obtain a HKSAR passport, you can still apply and you must obtain your HKSAR passport to be eligible to play at any of the tournament.

If you are interested to play at any of the events, please submit your application form on time. There will be no cost to you going through this process. All the necessary cost and schedule will be announced accordingly. There is no commitment at this point.

If you have any queries, please feel free to contact us.

PLAYERS WITH MORE THAN 1 PASSPORT

If you have more than 1 nationality, IIHF will be looking for the following documents before you can play for HKSAR National Ice Hockey Team:

If a player has or has ever had an additional citizenship or has multiple citizenships she must prove that she has participated on a consistent basis, for at least one hockey season and have been member of the new national association for at least 12 consecutive months during that period.

Therefore the following documents needs to be submitted for every multi-national player according the IIHF Regulations:

- · An affidavit from both parents declaring residency for the period in question
- Signature and stamp on a affidavit from the new national association confirming participation by this
 player and specifying the exact dates of participation
- Stamped and signed residency papers from the municipality for the period in question
- · School records for the period in question
- Approved game sheets for the period in question (3 per season from the beginning, middle and the end)
- School principal signature on original school letterhead confirming attendance in their school for the period in question

Please note that all of these documents must match each other which means must be provided for the respective time frame for over 730 days (e.g. 18.06.2002 – 24.08.2004).

II. **TERMS AND CONDITIONS**

Property Responsibility

The responsibility of the ice rink skating surface, the surrounding Plexiglas barrier, the rink support area, its interior and furnishings, the rink surfacing equipment and injury to other participants participating therein, will be that of each individual applicant.

Likewise, the applicant is responsible for any damage that might be caused by the throwing or shooting of pucks or other objects over the rink barrier into the mall common area where possible harm or injury may be caused to any person, storefront, or property of Event Venue or its tenants.

Security of Property

The Event Venue or HongKong Ice Hockey Association Limited ("HKIHA") will not be responsible for the loss or damage of the applicant's property before, during or after the HKWNIHT Program. It shall be the responsibility of each applicant to provide his/her own security.

Loss, Injury and Accidents

Neither the Event Venue or HKIHA, will be responsible for any injury, accident to person, nor loss of property inside the Event Venue and their respective loading docks, or surrounding area.

Use of the ice surface is entirely at the risk of the applicant. Accidents occurring on or off the ice will be the responsibility of the applicant and it is therefore suggested the applicant consider his own insurance coverage. This application constitutes a contract between the applicant and HKIHA, and a release of liability to HKIHA, its executive committee, for any time before, during or after games or practices organized by HKIHA. Each applicant is bound by the terms hereof.

Conditions of Use of Jerseys and Socks

All team jerseys and socks that may be lent out to players for the HKWNIHT Program are the property of HKIHA. Players must return any borrowed jerseys and socks once the competition is completed. Fines of minimum HK\$800 will be imposed for damaged, lost and non-returned jersey and socks. HKIHA reserves the absolute right to the use of the apparels.

Arrangement for Inclement Weather

The event will be cancelled if the Hong Kong Observatory reports black rainstorm warning signal, or 8 above tropical typhoon warning signal two hours before the event.

Appeals and Complaints

All appeals and complaints must be submitted in writing, typed or emailed to HKIHA within 24 hours of notification of the ruling. Referee reports are kept confidential.

Personal Data

The personal data collected in this application form will be for internal usage only. Under the Personal Data (Privacy) Ordinance, you have the right to request access to, and to request correction of, your personal data.
