### Terms and Conditions of Hong Kong, China Ice Hockey Association Limited Registered Ice Hockey Player:

- Registered Ice Hockey Player of The Hong Kong, China Ice Hockey Association Limited ("the Association") is open to any Hong Kong resident who is healthy, of rightful character and conduct and is willing to abide by the Constitution of the Association, observe its resolutions, disciplinary codes and membership fee payment schedule.
- Applicant for Registered Ice Hockey Player with the Association should truthfully fill in this form for approval. Applicant should specify the ice hockey team or division or club and league of which he/she is a member and currently playing for (if any).
- Under Constitutions of the International Ice Hockey Federation, no Registered Ice Hockey Player of the Association shall in the meantime enroll as an ice hockey member of other organizations of similar nature nor can he/she take part in activities thereof. Any Registered Ice Hockey Player of the Association participating in activities from other organizations aside from events held by the Association without the agreement from the Association shall be seen and treated as withdrawal from registration.
- All Registered Ice Hockey Player of the Association should observe the laws of Hong Kong, abide by social morality and by all means preserve the goodwill of the Association through solidarity, mutual assistance, encouragement and advancement. Responsibilities for any incidents or violation of law shall be borne by the individual Registered Ice Hockey Player whereas the Association and its affiliated Associations shall be exempted from the liabilities. The Association holds the absolute right to terminate the membership of any Registered Ice Hockey Player who has committed wrongdoing without having to render any reasonable explanations thereto.
- The Association's Registered Ice Hockey Player should pay attention to personal safety and to self-insure when taking part in any activities organized by the Association. Incidents occurred or injuries inflicted shall be the responsibilities of the parties involved whereas the Association and its affiliated Associations shall not be held responsible for these liabilities, legal or economic loss, arising therefrom. I shall be responsible for all such fees in relation to the incident if incurred.
- This application form should be completed with correct information in neat print while applicants are reminded to peruse these Terms and Conditions as well as the Constitution of the Association carefully.
- The Association reserves the absolute right to refuse any application without giving any reasons or explanations thereto.
- I, the applicant or parent/guardian of the applicant, hereby undertake, abide by and support the anti-doping policy of the International Ice Hockey Federation, the Sports Federation & Olympic Committee of Hong Kong, China, Hong Kong Anti-Doping Committee, Leisure and Cultural Services Department, the Association and other Government Departments. If the applicant violate any of these policies, the applicant may be subject to sanctions as set out in the respective policies.
