- 1. Membership of The Hong Kong, China Ice Hockey Association Limited ("the Association") is open to any holders of an HKSAR passport who are mentally and physically fit, have no criminal record, and have no history of breaching the Association's Code of Conduct. An application is deemed to represent that the applicant agrees and is willing to abide by the Constitution of the Association, observe its resolutions, disciplinary codes and membership fee payment schedule.
- 2. Any applicant for membership with the Association should truthfully fill in this form for approval. The Applicant should specify the ice hockey team or division or club of which he/she is a member. Such team/club should be registered under and recognized by the Association. Applicants who are not members of clubs recognized by the Association should put "yes" in the column requesting acceptance to join specific hockey team to be assigned by the Association. The Game Officials and Coaches Division will assign the applicant to one of the Association's hockey team according to the skill level of the applicant.
- 3. Under the Constitution of the International Ice Hockey Federation, no member of the Association shall in the meantime enroll as member of other organizations of similar nature nor can he/she take part in activities thereof.
- 4. All members of the Association should observe the laws of the Hong Kong Special Administrative Region and refrain from any action or speech which brings disrepute of the Hong Kong Special Administrative Region or the Central Government of the People's Republic of China. They shall abide by social morality and by all means preserve the goodwill of the Association through solidarity, mutual assistance, encouragement and advancement. Responsibility for any incidents or violation of law shall be borne by the individual member whereas the Association and its affiliated Associations shall be exempted from any liabilities whatsoever. The Association has the absolute right to terminate the membership of any member who has committed wrongdoing without having to render any reasons or explanations thereto.
- 5. Members should pay attention to personal safety and self-insured when taking part in any activities organized by the Association. Injuries incurred and the happening of incidents shall be the responsibilities of the parties involved whereas the Association and its affiliated Associations shall not hold responsibility for whatsoever liabilities, legal or economic loss, arising therefrom.
- 6. This application form should be filled in with correct information in neat print while applicants are reminded to peruse these notes and the Constitution of the Association carefully.
- 7. The Association reserves the absolute right to refuse any application without giving any reasons or explanations thereto.
- 8. Any application is deemed to represent that the applicant agrees and is willing to abide by the Anti-Doping Policy of the International Ice Hockey Federation, the Sports Federation & Olympic Committee of Hong Kong, China, the Hong Kong Anti-Doping Committee, the Leisure and Cultural Services Department, the Association and other Government Departments. An applicant violating any of these policies may be sanctioned in accordance with the respective policies.
